Privacy Policy

This website application ("Application") is operated by Elm Street Technology, LLC either directly or through one of its affiliates (individually and collectively hereinafter referred to as "Elm Street"). INFORMATION COLLECTED AND TRACKED BY ELM STREET

OUR COMMUNICATIONS WITH YOU (TCPA Consent for United States Residents)

A. EXPRESS WRITTEN CONSENT. By using the Elm Street Application and submitting your contact information, you are providing your express written consent to receive communications

from Elm Street, Elm Street Application or Real Estate Professional Users, at the email address and telephone numbers you entered into your account registration or contact form, or that you later provide to us or enter into the Elm Street Application, via live, automated or prerecorded email, text, or call.

We will make a commercially reasonable effort to comply with any communications from you opting out of email, but "unsubscribe" will automatically revoke your consent to further email communications, and we recommend that method. We may take up to 30 days to stop email communications if you use a method other than "unsubscribe". The "unsubscribe" link will also permit you to stop text communications. Your consent here also serves as your express written consent to electronic communications from us in the past.
